**Other Business**

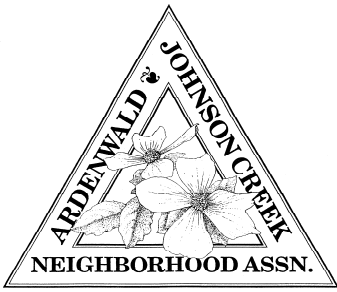
