## City Report - Grady Wheeler

Grady Wheeler covered a few points from the City of Milwaukie. He handed out a reference card for the upcoming Bond Measure, "6 Things To Know About Milwaukie's General Obligation Bond Measure." Updates on City projects included Riverfront Park, Monroe Street Waterline, Monroe Street Neighborhood Greenway, Monroe Street Paving, and ADA Ramp Enhancements. City Budget updates include upcoming work session Thu. Apr. 10, and Committee Meetings Thu., Apr. 24; Thu. May 29., and Thu. June 5; with City Council budget adoption by June 7.

Milwaukie City Councilor Mark Gamba reported three Neighborhood District Associations (NDA) wrote a letter in support of the Bond measure, with one NDA being neutral. The deadline for the letter submission was Monday, March 24, 2014.

QUESTION: Will the city start filling positions if the bond measure passes? Mark Gamba says he believes so. Code Enforcement is budgeted for one person at the time. The city manager makes the decision on staffing.

QUESTION: Was there polling? There was polling last fall and 63% are supportive of the measure.

### **Police Report - Steve Bartol, Police Chief**

Chief Bartol responded to a burglary call around SE 27th Ave. in a vacant house prior to attending the NDA meeting. The suspect was apprehended. He also discussed securing electronics. April 26, 2014, 10:00 am to 2:00 pm is drug turn-in/document shred day.

### **Rowe Middle School Hunger Grant**

Last month the NDA discussed the School Hunger Grant. The grant request amount was \$500. There was discussion about the amount and upcoming funding for other neighborhood events like the Summer Concerts. The Board discussed reducing the grant amount to \$200.

The NDA received a thank you note for the Officer of the Year Dinner.

A discussion was brought up about the appearances of resident yard and house exterior upkeep. The discussion included whether Code Enforcement has taken action or not. Code Enforcement has a staff of one. One suggestion is not to take an aggressive approach with enforcement, but to educate the community or reach out for volunteer work. Another comment was cautioning the NDA should not become like a "homeowner's association" on this matter.

Jeff talked about Marianne's discussion last month about the bylaws. There should not be a problem to comply with both Portland and Milwaukie bylaws. The issue addresses the voting requirements for Portland's insurance.

There are four concerts for this upcoming summer. Discussion included on receiving donations and grants. The past couple of years the NDA hasn't received much donations for the concerts for the five events.
