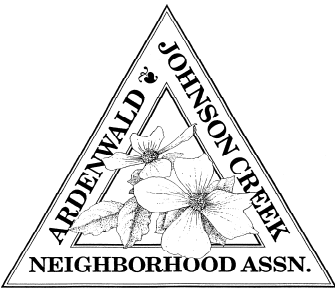
**Introductions**

**Police Reports**

Milwaukie Police chief Steve Bartol talked about expired vehicle tags ordinance. Milwaukie will not allow vehicles with expired tags after 30 days on Milwaukie public right of way. There was a fatal accident on Ore. 224 over the weekend. There was a HAZMAT situation on SE Main and SE Mailwell today (Jan. 26th). He also talked about the CodeRED "reverse 911" emergency notification (see Milwaukie Police Department's website or call the police department business line if without internet). Milwaukie Police is using Facebook and Twitter more.

**Clackamas Fire**

Brandon Paxton, Clackamas Fire Public Information Officer (PIO) reported on the HAZMAT incident that happened today. It was reported a business received a white powder substances. The powder turned out to be talcum powder. He talked about the Fire District board meeting that the board recommended a general funding bond on the elections. The bond expired in 2011. Operation Santa Claus is in its 40th year. He also presented the "File of Life" program (packets were available to all in attendance). Year end total calls was over 18,500 calls, an uptick from previous year. Milwaukie is the third busiest for emergency calls.

**City of Milwaukie**

Jason said Mitch couldn't attend tonight. He offered a brief overview of his duties. February 7, City Council will be having a community input session for 2015 goals. Email to 2015goals@milwaukieoregon.gov. Mayor Jeremy Ferguson resigned. They are looking for interim mayor. Anyone interested in mayor position can talk to city recorder Pat Duvall. City videos are on Comcast Channel 30 or on city website. He's also starting a quarterly neighborhood leadership meetings. Cambell Community Gardens has open spots. He also announced some North Clackamas Parks events. Planning Commissions will be discussing medical marijuana dispensaries. He announced a few public hearings dates. Updates on Neighborhood Main Streets. Zoning ZA-14-03 (C-L Commercial Limited amendment) was passed by city council. A comment about the government Channel 30 NDA announcements have outdated information.

**Milwaukie Museum Grant**

Grant "Frank" Hemer is asking for \$120 or more for grant to fund archiving for the Milwaukie Museum. He gave a brief overview of the museum. The grant request is to help fund archiving exhibits. The grand total to wrap and box exhibits of the project is \$840. He offered membership brochures. Museum is open Saturday and Sunday from 1:00 pm. to 5:00 p.m. Russ Stoll thanked the Hemers for ushering a new generation of curators at the Museum. Jeff received the grant request and will decide at the February 23, 2015 meeting. No motion made on grant request.

**Other Item/Public Comments**

Russ Stoll asked for a brief update on the Dec. 10th emergency meeting. Lisa Gunion-Rinker briefed it was an issue on the home demolition/rebuilding trend going on in the city. Russ discussed about the pathway near Eastmoreland Raquet Club. The land-use appeals hearing is on Feb. 2, 2015, 8:30 a.m. Ardenwald is appealing the ruling.

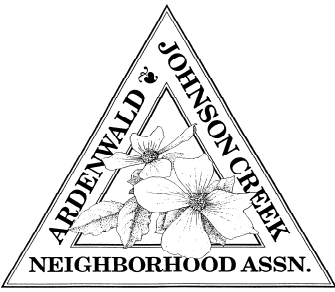
Marianne Colgrove said there will be a Watershed-wide event March 7, 2015, 9:00 a.m. to 12:00 p.m. with an after-work barbecue.

**Membership:** Jeff pitched some ideas for increasing membership.

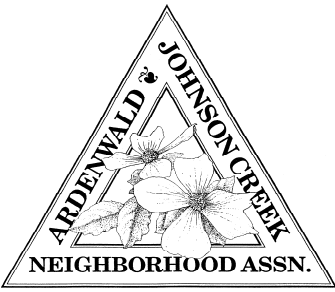
**Balfour Park:** Lisa updated on the parks. Some suggestions Plant sales in the spring.

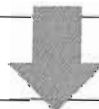

**Proposal – Process for Establishing a Residential Parking Permit Program**  
*(Revision to Traffic Regulation No. 237)*

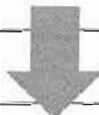
**1. Community-Initiated Request (via petition)**

- Concerned parties identify the area that would be regulated and circulate a petition that describes the problem and the proposed permit program
- Petition must present signatures in support, from 51% of addresses that would be regulated in the program
- Petitioners present the proposed program to the relevant NDA, at least for information if not for NDA support



**2. Assessment of Proposal**

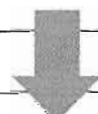
- Staff assessment:
  - Review the proposed area to confirm residential properties
  - Conduct an inventory to determine utilization of existing spaces during the proposed restriction time (minimum of 75% usage as rule of thumb)
  - Prepare recommendation to City Manager/Engineering Director about whether the proposed program is warranted
- Staff meets with petitioners and NDA to discuss findings and City recommendation about whether or not to proceed



**If Decision is to Move Forward on the Request . . .**

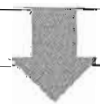
**3. Hold a Public Meeting**

- Notice of meeting sent to all affected addresses and other properties within approximately 1 block of regulated areas
- Meeting will include a presentation that reviews the problem and details of the proposed permit program
- Opportunity for discussion and input
- Announcement of upcoming ballot process



**4. Send out a Ballot**

- Ballots sent to all addresses (current residents) that would be regulated by the program (1 per address)
- Ballot includes information about the program:
  - Description of problem
  - Map of proposed program area
  - Details of proposed program (days/times, permit cost, etc.)

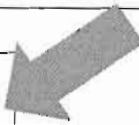


**5. Ballot Results Announced**

- At least 50% of the ballots must be returned, with at least 51% in favor of the proposed program for it to pass
- Ballot results determine whether or not the program will be established

**Final Opportunity to Appeal to City Council**

**If Decision is to Not Move Forward on the Request, Petitioner may Appeal to City Council**

## History

Of

## Milwaukie

Originally inhabited by the Chinook Indians and a stopping point for Hudson's Bay Company fur traders, Milwaukie was settled in 1847 by Lot Whitcomb, Henderson Luelling, and Joseph Kellogg and quickly became the largest town in Oregon. Whitcomb named our town and financed lumber, ship building, and flour industries. Luelling brought his tree wagon over the Oregon Trail with 700 grafted fruit trees, starting the Pacific Northwest nursery industry. Kellogg, a builder and ship captain, started building mills and ships. Most of the products produced were exported from Milwaukie Bay, a major port of call at the time.

Milwaukie was incorporated in 1903 with the 1<sup>st</sup> Ordinance limiting the storage of gun powder and explosives along the railroad lines. Water, sewer, sidewalk, and street improvements followed.

For over 150 years, Milwaukie has influenced politics and agriculture regionally as well as nationally. William Simon U'Ren, known as the father of initiative and referendum or direct democracy, and Monroe Sweetland, who is considered one of the fathers of the modern Democratic Party, changed local, state, and national politics. The fruit, vegetable, and flower industries thrived in Milwaukie. The well known Bing cherry was created here and the largest documented Pacific Dogwood tree blossomed inside the City.

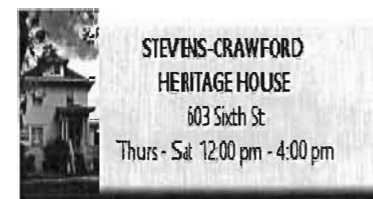

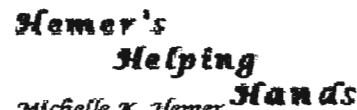

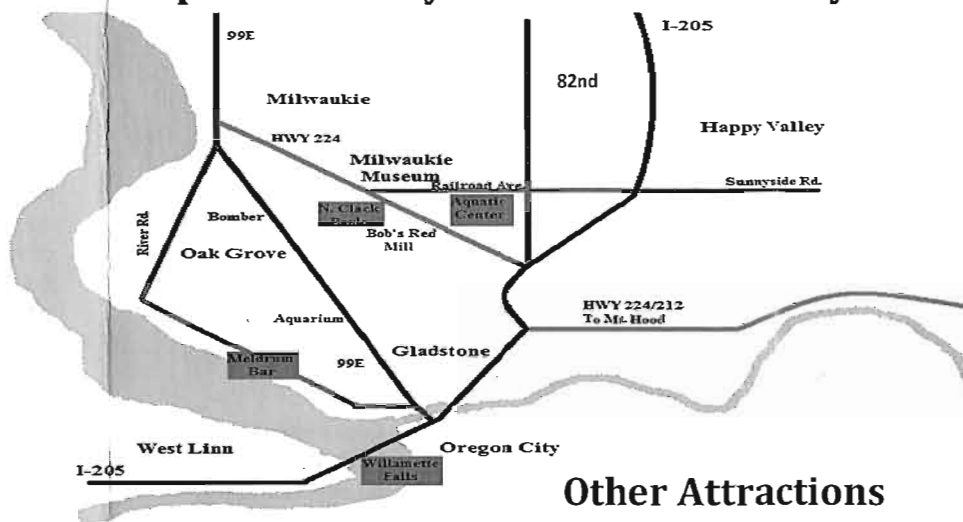
