Police Report - Mark Dye

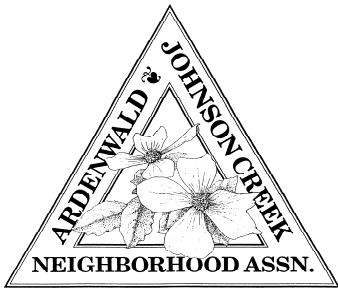

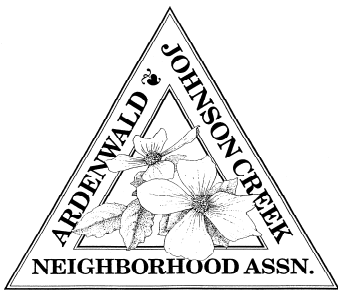
Additional Items & Public Comments

Land-Use: Matt Rinker reported on Lisa Gunion-Rinker's behalf about the hearing on Bureau of Development Service's Eastmoreland Racquet Club non-conforming use decision appeal hearing results should be back soon. Marianne Colgrove, Russ Stoll, Bryan Dorr, and Lisa Gunion-Rinker attended the appeal hearing on February 2, 2015. Marianne Colgrove and Lisa Gunion-Rinker testified. Marianne briefly provided an overview of the hearing and some possible outcomes.

Southeast Uplift: Marianne Colgrove said there is a SEUL Neighborhood Grants Program that just handed out money. The money was half of what it has been in previous years. The NDA has to apply and needs to be engaging with people. The grant is an annual event and hinges on the City of Portland's budget. They're still trying to mop of the street fee and reservoir capping. The Comprehensive Plan comments are due March 13th; there wasn't much in the Ardenwald area.

The Watershed wide event on March 7. Johnson Creek Watershed Council has a new director. Discussed fence building project.

Transportation: Angel Falconer emailed and is out at a trial in Eugene.

Public Safety Advisory Committee: The NDA does not have a representative. Jason Wachs explained the application that. Kim Travis spoke in interest of serving on the Public Safety Advisory Committee for Ardenwald.

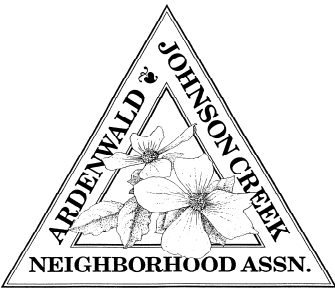

Council considering Habitat code change

CODE COMPLIANCE COORDINATOR, TIM SALYERS - (503) 786-7409



This is an example of a compliant habitat pile, except for the setback rule, if the new code were to be adopted.

The City Council is considering altering the Municipal Code to allow Habitat Piles with certain restrictions within City limits. Current code does not allow these types of piles as yard debris.

City Council would like to hear from you regarding these piles and what sort of restrictions or allowances you would prefer.

HABITAT PILE PROPOSAL UNDER COUNCIL CONSIDERATION

- Would have to be all natural vegetation material without lumber or treated wood.
- Could not be visible from pedestrian height while standing on the sidewalk or public right-of-way.
- Could not be located in the front yard.
- Would not be greater than 4 ft. tall or 10 ft. long or 10 ft. wide.
- Setbacks from structures and property lines are set at 50 feet right now, but would most likely be reduced under any code alteration.
- Total number of piles and amount of cubic feet allowed would depend on the lot size. See the table below.

Lot Size	Total space allowed for habitat piles	Number of piles allowed on lot
0 to 10,000 sq. ft.	100 cubic feet	1
10,001 sq. ft. to 1 acre	400 cubic feet	2
1.01 acre to 1.5 acres	800 cubic feet	3
1.51 acres to 2 acres	1,200 cubic feet	4
Larger than 2 acres	1,600 cubic feet	5
