Police Report

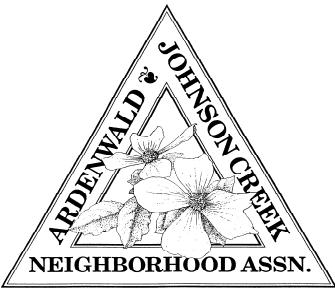

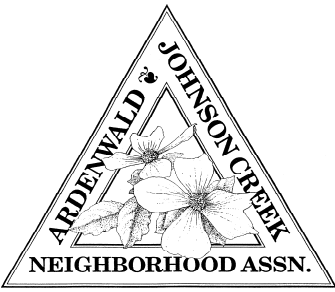
No public participation comments.

Intersection Painting at SE 30th and Sherrett

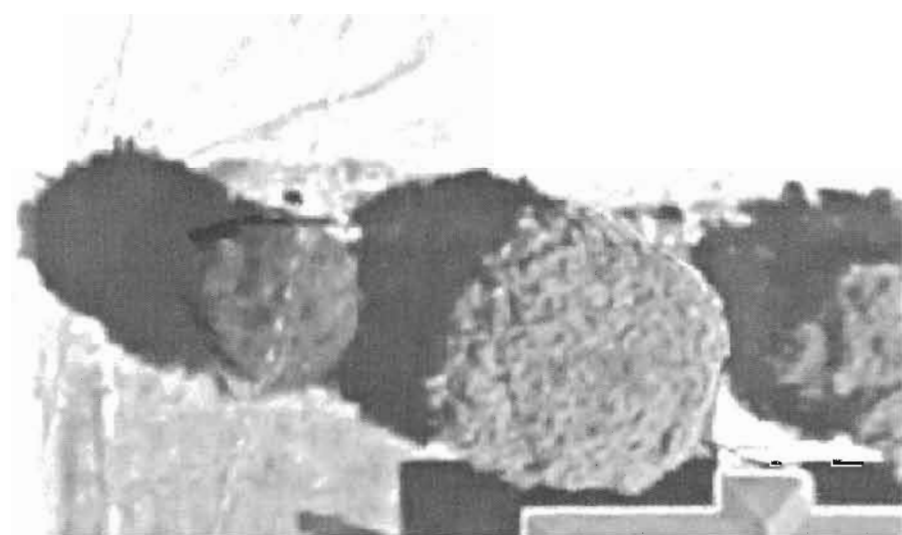
The section of SE Sherrett Street proposed in this application is located in Portland. The people who live in the houses on the north side of the street are residents of Portland and those on the south side reside in Milwaukie. It's a very popular route for people in the Ardenwald-Johnson Creek neighborhood to access the Springwater Trail, but it is very narrow and has no sidewalks, and often cars and trailers are parked on the street making visibility a problem for bike/ped users interacting with cars. My neighbors and I propose an "intersection repair" street painting, a design which we hope will remind users of all modes of travel that we are all connected to each other through this community and that we also share our environment with the natural world that surrounds us.

Neighborhood comments:



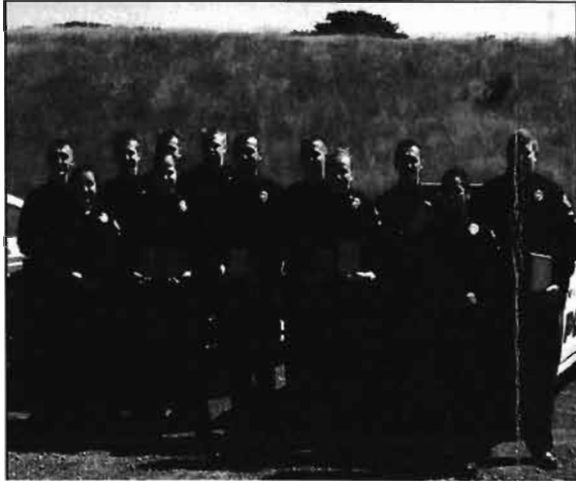
Feedback/guidelines from PBOT:

- No speech - no words or universally recognized symbols.
- No traffic control devices - if we want to show a train, bicycle, pedestrian, and car, that is fine, it just can't be shown in a way that PBOT would show them on a traffic sign or pavement marking.
- No copyright material.
- Big and simple shapes make it better for allowing everyone to participate and for easier installation and maintenance.









Cadet Training

Milwaukie Police Cadets are required to attend a twelve week academy once hired. The academy is held on consecutive Saturdays.

Police Cadets must attend monthly meetings (usually one or two evening meetings each month) in addition to occasional weekend training seminars.



For what purpose do Cadets use this training?

Cadets are invited each year to compete against other Cadet and Explorer Posts for trophies and other awards at local, state, regional, and national competitions.

Cadet Post members say the training they have received helped bolster their confidence, helped them become more goal oriented, and showed them how to work closely with others, promoting personal growth as well as learning leadership skills.

Examples of training include an overview of the judicial system, crime definitions, police patrol tactics, interview techniques, public relations, self-defense, firearms proficiency, basic first aid and CPR, hazardous materials, emergency vehicle operations, and crime scene analysis, among other topics of study.

What exactly is a Police Cadet?

A Police Cadet is a non-paid, volunteer position available to qualified persons ages 15 through 21 years. Much like an apprentice, Cadets learn about law enforcement by observing police procedures. Sponsored by the Milwaukie Police Department, cadets participate in police training and ride with the sworn police officers.

What does a Police Cadet do?

Cadets ride on patrol with police officers, mainly as observers. Cadets observe police officers performing their duties. Cadets perform duties such as directing traffic at accident scenes, and assisting with security details at City functions, i.e. parades and sports activities.



Minimum Qualifications

- Applicants must be between 15 and 20 years of age.
- Any person attending high school must maintain a minimum grade point average of 2.5. (You may not have a failing grade in any class.)
- Applicants cannot have a criminal history, or juvenile criminal history.
- Applicants 16 years of age, or older must have a valid driver's license. There is a reasonable expectation 15-year-old Cadets will receive their driver's licenses as soon as legally possible.
- Any applicant under 18 years of age must have signed consent from a legal guardian allowing the applicant to participate in the program.
