



## COAL EXPORT HEARINGS

Hearings for two of the five proposed coal export terminals will be held in early December. These hearings could be our best chance at stopping dirty coal exports through the Northwest.

**We Can, We Must, We Will stop these coal export proposals.** In addition to the noise, traffic congestion and hazardous coal dust, coal exports would make us one of the world’s largest exporters of climate-disrupting coal.
