An Atomic Bomb

It seems rather odd to attempt to write an article for the Artenwald News about such a remendous subject as an Atomic Bomb, but these are odd times and uncertain ones too. We used to be able to rely on our isolated geographical position to protect us from our enemies, but these days of world-girdling planes and ocean crossing submaries it is no longer possible to feel safe and secure in this wonderful country of ours.

Whether or not the Portland area would ever be subjected to an atomic blast is not for me to conjecture on, but we all know that if it did happen, many lives would be saved if we were prepared.

About three or four weeks ago, the Civilian Defense group for the Milwaukie area, which takes in the Fire District to which we belong, sponsored an open meeting at the Milwaukie High School on the subject of the Atomic Bomb. Present at the meeting were the chairman, John W. Jones of the Milwaukie Civil Defense group, his many aides in the Civilian Defense set-up, Leslie Peake of the Clackamas County Red Cross and Drs. Parker and Livermore from Reed College.

The meeting was advertised in the Milwaukie paper, over KGON, by hand bills given out by the stores and by word of mouth. Two of the men from Reed College, Dr. Parker and Dr. Livermore, who had been instrumental in the recent tests and instructions held there, were the guest speakers. Only about 10% of the available seats were filled. Does that indicate that people are not interested in this subject or believe that we could not possibly have anything like that happen here? I don't think so. But I don't understand why more people were not there.

My wife and I came away from the meeting with a small feeling of relief, even though the overall picture was appalling, because we understood a little more about the bomb and its effects.

Since then, the August 21st issue of Time magazine has carried a double page spread taken from a publication "The Effects of Atomic Weapons" put out by the Atomic Energy Commission and the Defense Department, and Life magazine of the August 28th features several pages on the bomb.

According to the men from Reed College, we would be safe in this area from a blast in dowtown Portland, if we had time to get down in our basements and lie on the floor as close as possible to the north wall, in a room with no windows. Time magazine says that slight damage (plaster and glass) will occur up to 8 miles from the center of the blast. This is for a bomb exploded 2,000 feet high as were the ones at Hir-

oshima and Nagasacki.

It is reported that at Hiroshima, 70,-000 people were killed and another 70,-000 injured. One of the Reed College men told us that at H iroshima, an air raid alarm had been sounded and then the "all clear" had been given when only a single American plane was observed fixing over. Many people were out in the streets in their way to work on this morning when the bomb fell. Probably if they had remained in the bomb shelters, many would not have been killed.

What if it should happen here? Would we know what part to play in the chaos which would follow, etc.? Not if we do not try to keep ourselves indicate the chaos which would follow, etc.? Defense activities.

Can we afford to stick our heads in the sand and say "It won't happen here?" I don't think so, do you?

A recent Portland paper carried this list of rules as a proposed measure to increase the safety of the many young bicycle riders in the city. While we are not in the city, these same rules should apply to our children's safety as well.

If you post them in some convenient spot in your home, at least your youngsters will know you didn't make up the various restrictions on the spur of the moment, just to "spoil their fun."

- 1. Obey all traffic signs and regulations.
- 2. Keep to the right side of the thoroughfare in the lane for slower vehicles.
- 3. Ride single file at a safe distance behind the vehicle ahead.
- 4. Stop to see that sidewalks or streets are clear before riding out of alleys or driveways or from behind parked cars.
- 5. Dismount and walk bike across heavily traveled streets.
 - 6. Signal for turns.
- 7. Carry parcels or books in a basket or luggage carrier.
 - 8. Do not carry passengers.
 - 9. Do not hitch onto other vehicles.
- 10. Do not do any "stunt" riding.
- 11. Have a white light on front for night driving, a red light or reflector in rear. Wear white or light colored clothing at night.
- 12. Keep bike in good condition.
- 13. Park bike in a safe and proper place, standing upright.

Oatmeal Cookies

1 cup sugar

1/2 cup shortening
6 T hot raisin juice
2 eggs
2 cups flour
1 cup rolled oats
1 cup raisins
1 ripe mashed banana
1 t soda
1/4 t salt
1 t vanilla
1 cup nuts optional

Mix sugar, shortening, hot raisin juice, eggs. Add rolled oats, raisins, banana. Sift flour, salt, soda, add slowly. Stir in vanilla. Drop by teaspoon on cookie sheet. Bake at 350 degrees for 12 minutes.

Civilian Defense

In view of the present nationwide emergency in connection with Civil Defense, we would like to present the following information to the people of Ardenwald about the Civil Defense setup in this area.

Louis Starr of Portland is the Oregon Area Civilian Defense Director appointed by the Governor. The Clackamas County Court appointed the County Sheriff to head the organizing of Civilian Defense Units in Clackamas County and he in turn asked Milwaukie to set up a Unit. The Unit was set up and it was found that to make an efficient unit, an area larger than just Milwaukie would have to be set up.

The designated area which includes Ardenwald is the Rural Fire Protection District. Since the main populated section in the area is Milwaukie, and as the fire fighting equipment is located there, Milwaukie is the headquarters for the Civilian Defense Group.

We are fortunate to have a man available in the area who has the time and experience to head the civilian defense set up, and that person is Mr. John W. Jones of Milwaukie.

Included on Mr. Jones' staff are the following people who are assisting him in various departments: Dept. 1—Deputy Director Thomas D. Tulford, Planning, Survey, Training and Supply. Dept. 2—Deputy Director H. C. Delp, Chief of Police of Milwaukie, Police activities in Milwaukie; and Deputy Director Leo Butler, Police activities outside of Milwaukie. Dept. 3—Deputy Director I. H. Stevens, Milwaukie Fire Chief, All Fire Department activities. Dept. 4—Deputy Director Dr. George Corti, all medical activities. Dept. 5-Deputy Director Fred Sperr, Public Works, Water Dept., and Utilities. Dept. 6- Deputy Director Harry Newman, Communications. Dept. 7—Deputy Director Leonard Mullan, Transportation and Evacuation. Dept. 8—Deputy Director Leslie Peake, Red Cross Activi-

In addition, Clyde Basler is 1st Assistant Director of the area and C. H. Nickle is 2nd Assistant Director. Mrs. A. Richardson is Executive Secreatary of the Civil Defense group and may be reached in the day time at Milwaukie 2-1811 or in the evening at home at EM 5977. Any inquiries about the group or information for the group may be handled directly with the Deputy Director involved or through Mrs. Richardson.

You may notice and wonder at the fact that most of these people are local Milwaukie people, but the purpose of having a Civilian defense organization is to have something set up that can function immediately in this area in case of diasaster so people were chosen who would normally be in the area involved. Coordinators for the various

areas involved have been appointed to assist in carrying out the organizational work of the group and to assist in any other way. The coordinator for Ardenwald is the Fire District Commissioner for this area, Charles Renard, 8600 S. E. 32nd Street, SUnset 2172.

The Civilian Defense organization needs various people and information to make its work effective. They have asked that all nurses, home or registered. who live in this area, all X-Ray technicians and all Hospital Corps personnel. either present or past, register with Dr. George Corti, who may be reached at his business phone of Milwaukie 2-2331 or EVergreen 1-1076 or at his home phones of Milwaukie 2-0531 or EVergreen 1-1214. Anyone interested in the communication set up, either operating or equipment, contact Harry Newman at his business phone of Milwaukie 2-4281 or EVergreen 1-5458 or his residence phones of Milwaukie 2-3456 or EVergreen 1-1022. Anyone who has a station wagon or equipment that might be used as an ambulance, contact Dr. Corti at the phones listed above and Leonard Mullin at his business phone of Mil. 2-5791 or his home phone of Mil. 2-1661.

Anyone with bulldozer equipment or heavy trucks contact Leonard Mullins at the above listed phones. Anyone who might have equipment that could be used for public works such as road graders, emergency power generating units, etc. contact Fred Sperr at his business phone of Mil. 2-9156 or EV. 1-1404 or his home phone of Milwaukie 2-5487.

The Civilian Defense Staff meets every other Tuesday at the Milwaukie City Hall at 8:00 P. M. and welcomes any visitors or suggestions that might improve its efficiency and usefulness.

Mr. John W. Jones, the Director of the District, when interviewed recently by a staff correspondent of the *Arden*wald News, made the following statement:

"I would like to express my appreciation to the Ardenwald Sheriff's Reserve and to all the people in that area who are cooperating so well with our Civilian Defense set-up. This is not a matter of local concern only. If the Civilian Defense groups are ever called into action, the well-being of the entire aera will be involved and the efficiency with which they operate will depend entirely upon the knowledge they possess as to their respective duties.

"In the event of an enemy attack, chaos and calamity can only be avoided by such groups as Civil Defense, because the Military will be too busily engaged to take care of civilian evacuation if it should become necessary. Therefore, it behooves every community to join with other communities to find out what has to be done and to cooperate with their leaders to forstall calamity and disaster.

"I hope that every person who has the opportunity will take the new revised Red Cross course in First Aid and that all women physically and mentally capable will take the Red Cross Nurses Aid program of training.

"The public should bear in mind that this training offered them through Civil Defense and the Red Cross is not only beneficial in time of war, but a preparedness against disaster of any type.

"I urgenty request every person who can possibly do so to donate blood to the Red Cross Blood Bank. This request is made not only for emergency use here but also due to the dire and immediate need for whole blood and its derivatives for the men now serving in Korea. May I suggest that you give your Clackamas County address when giving blood. A blood collection unit can be arranged for the Ardenwald district if enough people are interested."

Mr. Jones will appear at the next Ardenwald Community Club meeting, Sept. 7th, at the Ardenwald School, to tell us more about the Civilian Defense group and to answer questions. Remember this—the Civilian Defense organization is entirely on a voluntary basis; no one is getting paid for the work put in, so it behooves all of us to work together for our own protection.

The schedule of activities for this year will follow very closely that of past years; registration of pupils from 9:00 until 10:15 A. M. on Tuesday, September 5th, and building meetings and general meetings for the members of the faculty. The children will arrive at 9:00 A. M. meet their teachers, receive registration blanks to be filled out, get book lists, and other information and other information, and then be excused for the balance of the day. Regular classes with assignments (ugh!) will begin on Wednesday, September 6th.
