4. NDA minority Outreach: We sent out the NDA Statement regarding Black Lives Matter and one of the Kathy Hyzy, city councilor, responded. If we have her approval we would like to post it to our social media and website.

We also tabled the discussion from last week regarding how the NDA is including minorities including the inclusion of an armed police officer at most meetings.

Are there other things we are doing as an NDA that we haven't even noticed is not included. One issue we have heard before is child care.

We could put out a survey monkey to gather information about how to be more inclusive.

The board could discuss participating in Diversity Equity and Inclusion training, committing to reading a book, book club etc. there are also asynchronous ways to do a book club and don't require a meeting.

The Office of Civic Life in Portland offers trainings and there was a consensus that we should reach out and see what they offer for the board members

Perhaps we should put together, or ask for, fact sheets that highlight some of the main questions people have for the police to help cut back on the question and answer sessions with the police.

We could set out at the beginning of the meeting that we have some protocols establishing that we show respect for the entire neighborhood and to keep conversations neutral and fact based that allows us to set ground rules and we establish what the response is to comments or statements that we feel violate this protocol so no neighbor feels obligated to say something (perhaps the trainings can help with this). How do we decide to handle someone who is denigrating a certain part of the community?

<u>32nd street development</u>: We will be extending a general invite and welcome to the developer before the next city meeting, but she has not reached out to us. Lisa is also working on a letter that addresses issues in the code that have arisen from this topic.

<u>Yard signs</u>: NDA purchasing yard signs for Black Lives Matter and offering them to neighbors, ordering specific Milwaukie Signs (on back order) or signs of justice (\$11.50/sign) – going to check in with Jason Wachs about best way to do this

<u>Drive in movies</u>: first quote was for \$3,900 for a very professional movie, but keep working on it, reach out to Hector-Campbell and Lewlling to do a joint movie night
