4. Presentation Hillside Park Redevelopment Update – Alec Lawrence & Nate Grein from Related Northwest

a. Background:

- i. One of the oldest public housing developments in the state – built in the 1940s, 13.7 acres
- ii. Master plan started in 2018, in May 2022, Related Northwest selected as development in May 2022
- iii. Construction anticipated to start June/July 2024; expected completion in about 24 months of 275 months (June/July 2026)
- iv. Housing Authority of Clackamas County (HACC) has a goal of

building over 800 new units of affordable housing

- v. Phase 1 of the Project includes three buildings (A,B,C). Building A and B (175 units) will be owned by Related NW and HACC, with services provided by Impact NW and Unite Oregon. Building C (100 units) will be owned by HAC outright with a service provider Impact NW and HACC. Building C (is really intended as replacement for current Hillside project
- vi. Relocation process is going fairly week, residents will receive a considerable amount of support in moving and option to return to a unit at Building C, or can opt to retain mobile housing
- vii. Community resilience hub located on site to help with residents, Greenspace and garden beds are a huge priority for the residents so that has been translated into the design and culturally responsive services
- viii. Construction will begin with building C, then B then A, all four story buildings. Off leash pet area, 56 garden beds, bbq space, outdoor seating, Building A has a playground and deck overlooking courtyard

b. Updates:

- i. All permits have been applied for an are under review, working on securing financing for the project and finalizing the service plan with Impact NW & Unite Oregon
- ii. Residence relocation has begun
- iii. Strategizing around rest of the projects on the site including prioritizing affordable housing but with some for-sale housing
- iv. Building A is built around a heritage tree, will include a mural and ground floor property management and a pseudo public space to hang out etc, orange color scheme.
- v. Building B has more of a green color scheme.
- vi. Building A and B have 40 vouchers (20 regular vouchers and 20 with folks for disabilities), and then additional rooms have different thresholds for income
- vii. Building C faces Hillside Manor, community room. Each unit in this room has a voucher and each has a max income as well
- viii. Subsequent phases timeline and development depend on financing
- ix. To get a voucher, you need to go through HACC waitlist and then go through application process. For none voucher units you apply normally to the building and have to prove that your income meets the threshold requirement
